Celebrate Life International, Inc. continued its mission of making a significant difference in the lives of at-risk kids through the proven Teach One to Lead One Program. The program was implemented in new as well as existing public schools and juvenile court facilities and had a positive impact on a total of 3,315 students. This adds up to over 24,000 students impacted by the program since 1996. Students who participated in the Teach One to Lead One Program reported making positive changes in their own lives and influencing some of their peers to do the same. For example: -- 37% reported feeling empowered to positively influence their peers. -- 34% reported they no longer participated in underage drinking -- 24% reported that they no longer steal. The Teach One to Lead One Program had supporters residing in 207 counties in 42 states within the U.S. Further, the program was also active in the countries of Ecuador, El Salvador and South Africa.
